- ❖ Top line growth of 9.63%
- EBIDT up by 86% on y-o-y basis.
- ❖ PAT up by 363% on a y-o-y basis.
- Plastics division records volume and value growth of 9%.
- @home registered growth of 21% and achieved cash profit.

Due to of the inherent nature of the business of the Company, although the comparison with the figures of the preceding quarter is not comparable, the PBT has increased by 18% against drop in sales by 7% on a q-o-q basis.

The Company is undergoing a transformative program focusing on the enhancement of the strategic and operational efficiencies of all its businesses. This will enable the Company to be on an accelerated growth path with improved efficiency and profitability.

Q1 FY16 was a strong quarter for the Company wherein the plastics business grew by 9% both in value as well as volume terms. Net sales registered by the Company during Q1 FY16 was ₹ 457.55 crores as against ₹ 417.34 crores of Q1 FY15– a growth of 9.63% on y-o-y basis. PAT for Q1 FY16 stood at ₹ 25.30 crores, a jump of 363% on a y-o-y basis against the PAT of ₹ 5.47 crores during Q1 FY15.

The Company anticipates that the raw material prices shall remain range bound during the FY 2016 as against the volatility witnessed during the second half of FY 2014-2015.

The Company's retail business under brandname '@home' registered a healthy growth of 21% on a y-o-y basis, recording net sales of ₹ 50.48 crores for Q1 FY16 vis-a vis ₹ 41.70 crores for Q1 FY15.

The Company has expended ₹ 9.33 crores towards capital expenditure for it plastics business.

The Company's Indo-German Joint Venture viz Nilkamal Bito Storage Systems Private Limited grew by 119% on a y-o-y basis; whereas the Indo - US Joint Venture viz. Cambro Nilkamal Private Limited recorded de-growth of 7.69% on a y-o-y basis.

The Company's subsidiary viz Nilkamal Eswaran Plastics Private Limited at Sri Lanka had displayed a satisfactory performance coming out of red and posting net profit of ₹ 1.52 crores on a y-o-y basis whereas the other subsidiary viz. Nilkamal Crates and Bins FZE at Ajman, UAE performed as anticipated by the Company.
