During Q1 FY18, the Company achieved turnover of ₹ 524.39 crores vis-à-vis ₹ 495.78 crores of corresponding quarter of previous year, rise of 6%, whereas the PBT for Q1 FY18 stood at ₹ 33.25 crores as against ₹ 46.60 crores of the Q1 FY17. The Company recorded EBIDT of ₹ 47.60 crores for the period under review as compared to ₹ 62.27 for quarter ended June, 2016. The plastics business of the Company exhibited a volume growth of 2% and value growth of 4% on a y-o-y basis and also recorded turnover of ₹ 468.36 crores vis-à-vis ₹ 445.91 crores of corresponding quarter of previous year.

During Q1 FY18, the Company has achieved growth in its topline, however the bottom-line was affected on account of additional spends towards the ongoing advertisement for brand reinforcement, rise in routine expenditure and other one-off, non-recurring operational expenses. Further, June 2017 also saw an impact on the sales volume of the Company due to the GST being rolled-out with effect from July, 2017.

The Company's retail business '@home' achieved a turnover of ₹ 56.03 crores, a growth of 12% on a y-o-y basis and recorded PBT of ₹ 0.92 crores. All the stores, except one, has achieved profits at store level. Further, during the period under review, one of the store situated at Hyderabad was closed.

The Company's mattress business has achieved sales of ₹ 11.72 crores as against as ₹ 7.86 crores of the Q1 FY17. Further, during the quarter, the commercial production of bubble guard had also commenced.

During Q1 FY18, the Company has incurred a capital expenditure of ₹27.89 crores towards building and office premises, moulds, plant & machineries, office & factory equipment, furniture & fixtures, and electrical installation etc.

Both the Company's joint venture companies displayed a turnover growth whereas the turnover of the subsidiary companies had seen a drop and the profits were under constraints for all its joint venture as well as subsidiary companies.
